I extend this release of liabilities to the above mentioned parties to cover any and all action which may be contemplated or brought about by any member of my family, heirs or other interested parties on my behalf at any time. **I AGREE THIS FULL LIABILITY RELEASE / HOLD HARMLESS AGREEMENT SHALL BE LEGALLY BINDING, COMMENCING ON THE DATE OF SIGNING AND WILL TERMINATE ON 12/31/2024.**

I further acknowledge and understand that during these courses I will be using a firearm, or assisting in training others to use firearms, which are a deadly weapon, with live ammunition, and that I will never do anything, or refrain from doing anything, which is inconsistent with my own personal safety as well as the safety of others at risk, I will be asked by Kimberly Jacobs {KJ}, and/or any Range Safety Officer (SO) and/or the Range Facility (RF) representative to withdraw from the training without my receiving any course credit or monetary refund whatsoever.

I am aware that this training, if used in an improper manner, can cause injury or death, and I am aware that (KJ), (KT), and the {RF} cannot and will not be held liable for my actions, while I am properly and lawfully, or improperly or unlawfully, using the information, procedures, and methods taught in this course.

I hereby state that I am taking this firearms course for the lawful purposes of self- protection, and personal security, I further state that I am not a fugitive from justice, and that I am lawfully able to own and use firearms.
